6. Chairman of the Board of Directors

Effective January 1, 2025, Yoshihiko Hatanaka, an external director, will assume the role of Chairman of the Board of Directors. This appointment aims to further strengthen the separation of execution and oversight, thereby enhancing the effectiveness of the Board of Directors.

Nomination of Yasuhiro Nakajima as Candidate for New External Director

1. Reason for Appointment

Shiseido has established "BEAUTY INNOVATIONS FOR A BETTER WORLD" as its mission within its corporate philosophy, "THE SHISEIDO PHILOSOPHY," and positions corporate governance as the foundation for achieving sustainable growth through the fulfillment of that mission.

In this context, External Directors are regarded as one of the key elements of corporate governance, believing that the role in monitoring business execution from an independent standpoint is crucial for maximizing corporate and shareholder value. Therefore, it is important for External Directors to demonstrate high capabilities based on diverse perspectives and experiences as members of the Board of Directors.

Mr. Nakajima possesses extensive experience and achievements in accounting audits and advisory services as a Certified Public Accountant, as well as insights and accurate problem identification regarding the management of global companies. By appointing him as an External Director, he is expected to provide advice, opinions, and oversight from a financial and accounting expert's perspective on the company's management and financial strategies, which are globally oriented. It is believed that his appointment will further enhance the effectiveness of the Board of Directors, and thus, he has been selected as a candidate for a new External Director.

Furthermore, based on our "Criteria for Independence of External Officers," Mr. Nakajima's concurrent positions and transactions with the Shiseido Group have been examined, confirming that he maintains a high level of independence from the group.
